Speeding Costs You" campaign- already done in Orleans, next for Riverview and Stittsville. News of the campaign is spread via community flyers, newspapers, etc. City puts up signs in the community, as well as speed boards at various locations in the area (on the property for 1 day from about 7-7, during non-winter months, on a volunteer basis). Sign-up sheets for volunteers for this campaign will be at the AGM.
