




How did you hear about this contest?

Planning and Development Report

Planning and Development Update from the Riverview Park Community Association:

1. Proposed Tremblay Multi-Use Connection (Terminal Avenue to Tremblay LRT Station). Project remains on hold as in February 2025, the federal government announced it was **now planning to build a High-Speed Rail (HSR).** The HSR team has had initial meetings with senior City officials and will be making a presentation.

The RPCA will get an update after VIA meets with City officials to discuss the HSR. The RPCA has also been put in touch with the HSR team working on this project.

2 Traffic Safety Issues. Following a pedestrian being killed at the intersection of Smyth Road with Russell Road and Othello Avenue earlier in May, Councillor Marty Carr noted that this intersection was included as part of the Elmvale Acres Secondary Plan. This is a Development Charges (DC) project that has been included in the 2025 DC Background Study Update, which is planned for Council approval later this year. Once the DC Update is approved, we anticipate that this project will move forward fairly quickly, with functional design tentatively planned to begin in 2026. Overall, the project is expected to take three to four years to complete, from the functional planning stage, to detailed design, and construction. The City owns the triangular portion of land on the North-East quadrant of the intersection bordered by Russell and Smyth, which was purchased to facilitate the re-alignment.

In the Transportation Master Plan, there is a <u>cycling project</u> in the list that would see separated cycling lanes on Russell Road and St. Laurent Boulevard from north of Southvale Crescent to Bourassa Street. As part of this, there was a commitment to review the possibility of bike lanes west of St. Laurent Boulevard (On Smyth) to Othello Avenue. While this project was identified as being implemented past a 7 to 10-year timeline, I am hopeful that staff will consider bundling this project with the realignment project above.

- 3. Potential Housing Complex at 1460 Riverside Drive In early March 2025, the National Capital Commission (NCC) in collaboration with the Canadian Mortgage and Housing Corporation publicly announced it was seeking a proponent for the construction of residential housing at 1460 Riverside Drive (the empty lot directly across from the Cancer Survivors Park) According to the announcement, the parcel has potential for more than 200 housing units in an g environment focused on active transportation and is part of the Canada Public Land Bank initiative to make public land available for housing construction. No further details are available
- 4 Alta Vista Transportation Corridor (AVTC) Public Consultation Last week, the City released an updated draft of the new Transportation Master Plan (TMP) Capital Infrastructure Plan recommending removal of the northernmost section of the AVTC (between Hurdman Station and Nicholas Street. This section would have been the most important remaining part of the AVTC to build as it would have required a new bridge over the Rideau River. Currently, a portion of the property (adjacent to the 170 Lees Ave apartment building) is zoned R4UD and the two other lots are O1 and O1C. Some people will want all of the land to be parkland but there are good arguments why housing would be allowed on part of it.

The section of the AVTC south of Smyth remains in the TMP as does the Hospital Link portion which could still be widened to four lanes. Concerns remain about the need for these two sections to remain in the TMP, given potential costs and impact of dumping additional traffic onto Smyth Road, Alta Vista Drive and Riverside Drive. The comment period on the TMP closed on May 12) Geo Ottawa lists much of the land South of Smyth as O1 – Parks and Open Space, but there are parcels near Walkley (2027 Walkley) that are R3 and R5. geoOttawa

The RPCA requested copies of any relevant traffic studies conducted after the construction of the AVTC Hospital Link to determine any impact that this Link road has on vehicular traffic flow and patterns. In addition, Councillor Menard's office agreed to look into the process by which land removed from the TMP could be converted and re-zoned as park land or greenspace.
